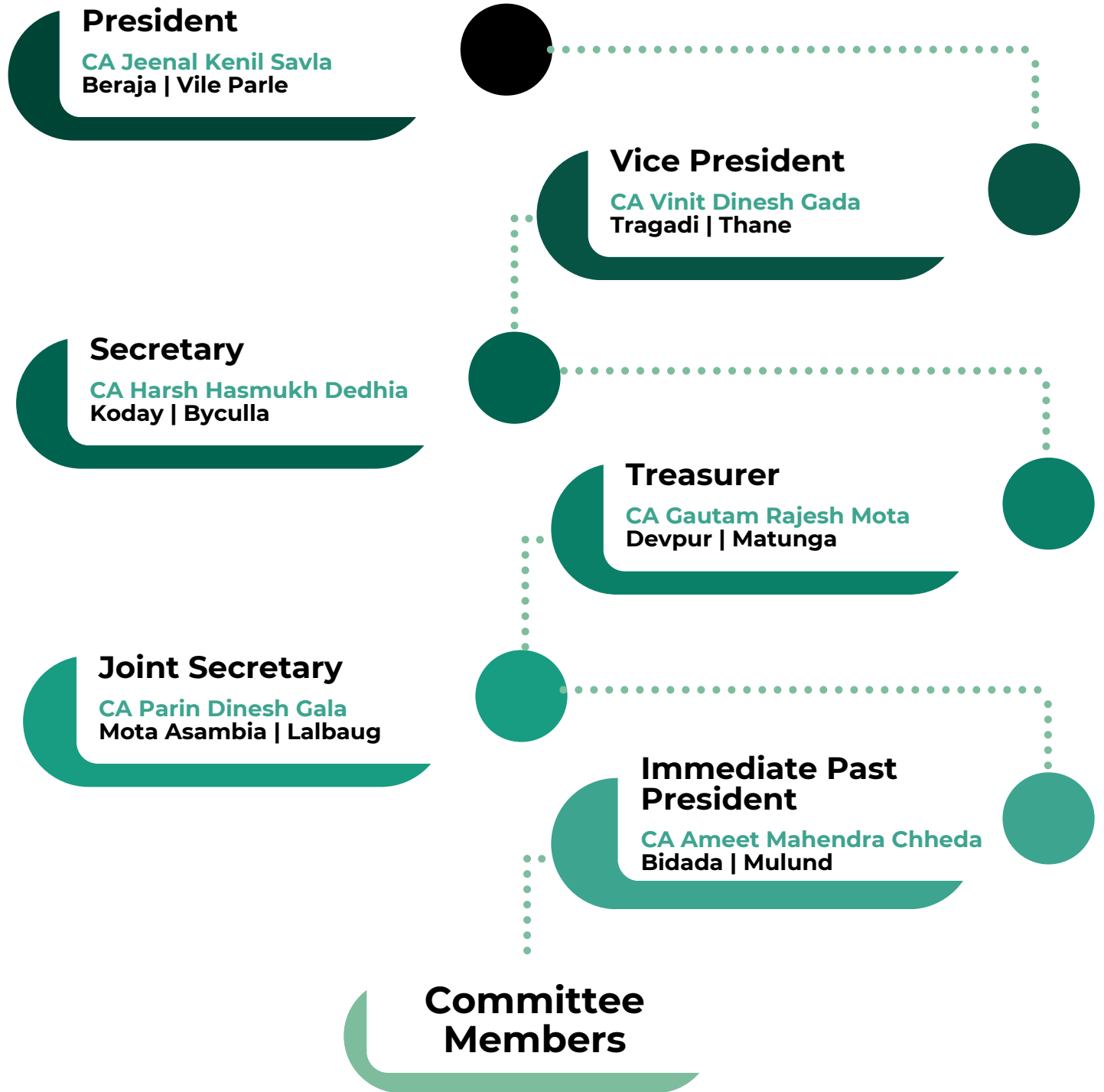

## AWARDS EVALUATION PROCESS

Comprehensive and meticulous approach was taken to ensure fairness and objectivity in the selection process of CVOCA Entrepreneurship and Leadership Awards 2024. Delicate balance was maintained for financial parameters duly respecting confidentiality and sensitivity. At all levels extreme confidentiality has been sought to be maintained on financial and other financial data. Here's a summary of the steps outlined:

- 1. Category Selection:** Categories and the number of awards were decided to recognize excellence in Entrepreneurship, Leadership, and Professional Excellence.
- 2. Criteria Development:** Criteria for evaluating nominations were developed through intense brainstorming sessions by a group of independent senior professionals.
- 3. Framework Preparation:** A robust framework considering over 50 financial and non-financial parameters was prepared, and weights were assigned to ensure objectivity and subjectivity.
- 4. Technical Scrutiny:** Technical scrutinizers evaluated nominations based on the provided data, ensuring confidentiality.
- 5. Jury Panel:** It consists of seven non-KVO distinguished, unbiased, and renowned jurors.
- 6. Individual Assessment:** Jurors individually assigned marks to nominees based on the criteria and shared a list of top nominations in each category which is published in the book.
- 7. Shortlisting:** Then further rigorous assessments took place in which top 3 to 5 nominations in each category were shortlisted based on the average marks assigned by the jurors.
- 8. Final Decision:** The name of the final awardee in each category was placed in sealed envelopes by the jurors after the final round of assessments. These envelopes will be opened today on 6th April, 2024.

The decision of the Jurors shall be final and binding.

Best of the efforts are made that structured and transparent process ensures that deserving nominees are recognized for their achievements in entrepreneurship, leadership, and professional excellence. However, intense competition is seen in few categories where the differences in marks between the winner and the runner-up are minimal. In such cases, it reflects the high calibre and excellence of all the nominees.

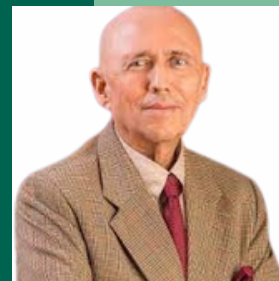

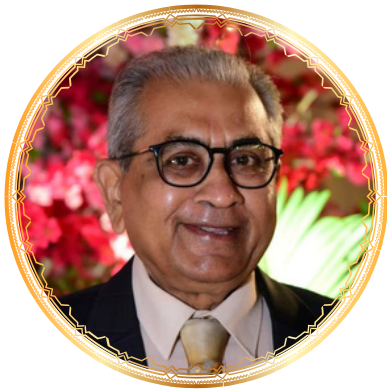

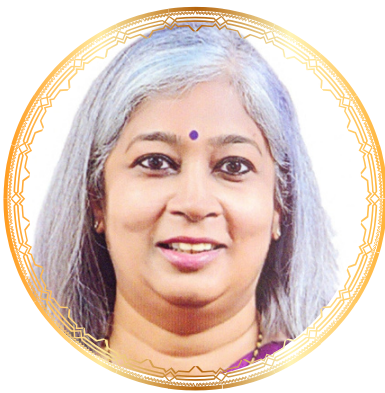
